## 1. NSW SKILLS LIST UPDATED – VERSION 13.5

The NSW Skills List has been updated. This update covers changes as a result of:

- updates to Training Packages;
- updates to Vocational Training Orders (VTOs);
- additional NSW Fee Free qualifications.

Versions 13.5 of the NSW Skills List and *Smart and Skilled Prices and Fees Schedule* are effective as of 15 February 2023.

Version 13.5 of the Smart and Skilled Prices and Fees Schedule includes indicative student fees for all qualifications tagged as NSW Fee Free (NFF). However, the Department will pay these student fees in addition to standard subsidies for all Smart and Skilled eligible students when the Smart and Skilled provider applies the relevant waiver at the time of enrolment – see Smart and Skilled Update No. 192 (5 December 2022).

The fees for Smart and Skilled students enrolled in these qualifications who meet the enrolment and commencement date timeframes above will be retrospectively adjusted to \$0. Providers of affected students will be notified when this is done and will be required to refund students any fees paid, as advised in Smart and Skilled Update No. 192 (5 December 2022).

## 2. CHANGES TO SMART AND SKILLED QUALIFICATION PRICES

New Smart and Skilled qualification prices are being introduced for superseding qualifications. The Department has reviewed the prices for seventy-five (75) superseding qualifications. These qualifications were reviewed on their merits using the IPART methodology.

The Department received a formal request to review the price of the Certificate III in Roof Plumbing (CPC32620). Following the review using the IPART methodology, the price will be increased by \$1,040 as detailed in **Table 2**.

All price increases will take effect for commencements from **1 January 2023**.

The price increases will go live in STS Online as soon as possible to apply to all new enrolments in these qualifications.

Regarding students that commenced training on or after 1 January 2023, the price increases will be factored into future milestone payments as providers submit activity data as normal. Providers might receive a notification of price and fee recalculation for students granted Credit Transfer / Recognition of Prior Learning when the prices go live in STS Online.

**b. Qualification price and fee decreases from 1 July 2023**

Nine (9) qualifications will receive a price decrease and are listed in **Table 3**. One qualification will receive a fee decrease and is listed in **Table 4**.

All price decreases will take effect for commencements **from 1 July 2023** and will only apply to new commencements after that date.
